#### **Priorities**

**Priority 1:** Strategic Plan Objective #1.1 Improve, align and remove barriers for academic programs to ensure they are accessible to and differentiated for all students to achieve high levels of learning.

Goal 1: Student data will be analyzed using a campus-wide system with the expected outcome being growth in reading and math for all student groups.

Performance Target: 120% growth in Q4 and Q5; 110% growth in Q3, 100% growth in Q1 and Q2

Expected Result: Students will meet their projected growth as measured by fall to winter MAP and fall to spring MAP.

**Goal 2:** By the end of the academic year, 100% of teams will collaborate to align lesson plans and assessments using the Collaborative Team Framework and Instructional Cycle for Success.

Performance Target: 120% growth in Q4 and Q5; 110% growth in Q3, 100% growth in Q1 and Q2

Expected Result: Students will maintain or accelerate their MAP projected growth percentage (fall to winter and fall to spring).

**Priority 2:** Strategic Plan Objective #4.2: Implement interventions and systems of support to ensure a safe, orderly and respectful learning environment.

Goal 1: Implement a school wide system to reduce classroom discipline incidents by fostering a consistent and positive behavioral environment.

**Performance Target:** By establishing and consistently reinforcing clear behavioral expectations, we expect to create a more positive classroom environment that minimizes discipline incidents.

**Expected Result:** By the end of May 2025, we will reduce the percentage of discipline incidents occurring in the classroom by 10%.
