Priority 1: Develop and deliver systems for learning that articulate expectations and provide support for all staff, campus administrators and district office leaders to ensure engaging, high levels of learning for all students.

Goal 1: By the end of the 2024-2025 school year, teachers will enhance Tier I instruction by integrating high yield instructional strategies.

Performance Target: By the end of the 2024-2025 school year, in Reading:

75% of all K-5 students will score Approaches or above as measured by Reading STAAR and Reading EOY MAP.

Third Grade students will score 41% Meets or above as measured by Reading STAAR and Reading EOY MAP.

Fourth Grade students will score 62% Meets or above as measured by Reading STAAR and Reading EOY MAP.

Fifth Grade students will score 58% Meets or above as measured by STAAR and EOY MAP.

By the end of the 2024-2025 school year, in Math:

70% of all K-5 students will score Approaches or above as measured by Math STAAR and Math EOY MAP.

Third Grade students will score 38% Meets or above as measured by Math STAAR and Math EOY MAP.

Fourth Grade students will score 51 Meets or above as measured by Math STAAR and Math EOY MAP.

Fifth Grade students will score 37% Meets or above as measured by Math STAAR and Math EOY MAP.

By the end of the 2024-2025 school year, in Science:

70% of all 3-5 students will score Approaches or above as measured by Math STAAR and Science EOY MAP.

Fifth Grade students will score 33% Meets or above as measured by Science STAAR and EOY MAP.

Expected Result: Teacher effectiveness at designing learning that engages all students at the Tier I level, and use of data to make adjustments throughout instructional units will decrease student learning gaps.

Goal 2: By the end of the 2024-2025 school year, teachers will provide consistent and targeted intervention for all students performing below the Meets Proficiency Level on MAP and or STAAR to ensure a minimum of one year's growth.

Performance Target: By the end of the 2024-2025 school year, in Reading:

75% of all K-5 students will score Approaches or above as measured by Reading STAAR and Reading EOY MAP.

Third Grade students will score 41% Meets or above as measured by Reading STAAR and Reading EOY MAP.

Fourth Grade students will score 62% Meets or above as measured by Reading STAAR and Reading EOY MAP.

Fifth Grade students will score 58% Meets or above as measured by STAAR and EOY MAP.

By the end of the 2024-2025 school year, in Math:

70% of all K-5 students will score Approaches or above as measured by Math STAAR and Math EOY MAP.

Third Grade students will score 38% Meets or above as measured by Math STAAR and Math EOY MAP.

Fourth Grade students will score 51 Meets or above as measured by Math STAAR and Math EOY MAP.

Fifth Grade students will score 37% Meets or above as measured by Math STAAR and Math EOY MAP.

By the end of the 2024-2025 school year, in Science:

70% of all 3-5 students will score Approaches or above as measured by Math STAAR and Science EOY MAP.

Fifth Grade students will score 33% Meets or above as measured by Science STAAR and EOY MAP.

Expected Result: Teacher effectiveness at providing targeted intervention and making adjustments based on progress monitoring will close student learning gaps.

Priority 2: Implement interventions and systems of support to ensure a safe, orderly and respectful learning environment.

Goal 1: During the 2024-2025 school year, teachers will implement classroom systems to ensure a safe and organized learning environment for all students.

Performance Target: Teacher Engagement Walkthrough data will increase to 88% student engagement per classroom.

Expected Result: Teachers will implement classroom routines and procedures that increase student learning time and compliance with classroom expectations.
