#### **Priorities**

**Priority 1:** Strategic Plan Objective 1.2- Develop and deliver systems for learning that articulate expectations and provide support for all staff, campus administrators and district office leaders to ensure engaging, high levels of learning for all students.

**Goal 1:** Thomas will prioritize engaging students in cognitively complex tasks that promote deep learning and critical thinking and enhance instructional rigor by using the collaborative team framework.

Strategic Performance Objective 1.2: Develop and deliver systems for learning that articulate expectations and provide support for all staff, campus administrators, and district office leaders to ensure engaging, high levels of learning for all students.

**Performance Target:** Achievement status & Growth Report - Persenct of Projected Growth Met for each grade level will be a least 100%. Student Growth Summary Report - Percent Met Projection for each grade will be at Least 60-65%. Student Growth Summary Report - Student Median Conditional Growth Percentile for each grade will be at least 50th percentile.

The percent of 3rd, 4th & 5th-grade students that score Meets grade level or above on STAAR Reading will increase (from 41/38/47) to 50% by the end of the 24-25 school year.

The percent of 3rd, 4th & 5th-grade students that score Meets grade level or above on STAAR Math will increase (from 43/32/43) to 50% by the end of the 24-25 school year.

The percent of Special Education students that score Meets grade level or above on STAAR Reading will increase 10% (from 15/5/24) by by the end of the 24-25 school year.

The percent of 5th-grade students that score Meets grade level or above on STAAR Science will increase (from 43 En/9Sp) to 40% by the end of the 24-25 school year.

Expected Result: Strong school leadership and planning, strategic staffing, high quality instructional materials and assessments, positive school culture, and effective instruction

**Priority 2:** Strategic Plan Objective 1.1 - Improve, align and remove barriers for academic programs to ensure they are accessible to and differentiated for all students to achieve high levels of learning.

**Goal 1:** By the end of the 2024-2025 school year, teachers will improve Tier 1 instruction by incorporating high-yield instructional strategies and techniques to accelerate student learning through the utilization of district-approved curriculum and consistent opportunities for students.

**Performance Target:** The percent of 3rd, 4th & 5th-grade students that score Meets grade level or above on STAAR Reading will increase (from 41/38/47) to 50% by the end of the 24-25 school year.

The percent of 3rd, 4th & 5th-grade students that score Meets grade level or above on STAAR Math will increase (from 43/32/43) to 50% by the end of the 24-25 school year.

The percent of Special Education students that score Meets grade level or above on STAAR Reading will increase 10% (from 15/5/24) by by the end of the 24-25 school year.

The percent of 5th-grade students that score Meets grade level or above on STAAR Science will increase (from 43 En/9Sp) to 40% by the end of the 24-25 school year.

Expected: 80% of students in each grade will meet or exceed their expected growth on MAP (Reading, Math, Science).

**Expected Result:** Improved teacher effectiveness in planning, instructional design, and Tier 1 delivery with high-yield strategies will lead to better monitoring of student growth, reducing performance gaps on MAP, STAAR, and TELPAS, and increased overall achievement.

**Goal 1:** Thomas will improve student attendance by implementing specific incentives and fostering a positive school culture. These strategies will focus on motivating students to attend school regularly through rewards, and recognitions.
